## RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125 , Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

FERRIS and ARLENE F. FERRIS for a SPECIAL EXCEPTION TO ALLOW THE PARKING OF ONE (1) MOBILE HOME AS A TEMPORARY RESIDENCE on the West $1 / 2$ of the North $1 / 2$ of Tract 28 , Block 'A', LOXAHATCHEE GROVES, in Section 18, Township 43 South, Range 41 East, as recorded in Plat Book 12, page 29. SUBJECT TO an easement for ingress and egress over the East 30.00 feet of the South 300.00 feet thereof; TOGETHER, WITH, an easement for ingress and egress over the East 30.00 feet of the West $1 / 2$ of the South $1 / 2$ of said Tract 28, and the South 30.00 feet of the East $1 / 2$ of the South $1 / 2$ of Tract 28. Said property located 450 feet west of 'B' Road, approximately . 1 mile south of North Road (40th Street), and approximately 2 mile west of 'A' Road in an AG-Agricultural District, was approved as advertised subject to the following condition:

1. The term of the Special Exception allowing the parking of the mobile home as a temporary residence shall be limited to a maximum of five (5) years because of the changing character of the area.
