FERRIS for No. 79–172 a SPECIAL EXCEPTION TO ALLOW THE PARKING OF ONE (1) MOBILE HOME AS A TEMPORARY RESIDENCE on the West 1/2 of the North 1/2 of Tract 28, Block 'A', LOXAHATCHEE GROVES, in Section 18, Township 43 South, Range 41 East, as recorded in Plat Book 12, page 29. SUBJECT TO an easement for ingress and egress over the East 30.00 feet of the South 300.00 feet thereof; TOGETHER, WITH, an easement for ingress and egress over the East 30.00 feet of the West 1/2 of the South 1/2 of said Tract 28, and the South 30.00 feet of the East 1/2 of the South 1/2 of Tract 28. Said property located 450 feet west of 'B' Road, approximately .1 mile south of North Road (40th Street), and approximately .2 mile west of 'A' Road in an AG-Agricultural District, was approved as advertised subject to the following condition:
