Nichols, Vice President, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO RM-RESIDENTIAL MULTIPLE FAMILY DISTRICT (MEDIUM DENSITY) of a tract of land lying in Section 6, Township 44 South, Range 37 East, more particularly described as follows: Commencing at the North 1/4 corner of Section 6, Township 44 South, Range 37 East; thence Southerly along the East line of the Northwest 1/4 of Section 6 a distance of 729.23 feet; thence Westerly along a line parallel with and 729.23 feet Southerly of the North line of Section 6 a distance of 1578.37 feet to the true Point of Beginning; thence continuing along a line parallel with and 729.23 feet Southerly of the North line of Section 6 a distance of 1058.10 feet; thence Southerly along the West
