RESOLUTION APPROVING ZONING PETITION

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session t h e 26th day of September , that petition No. 79-188 the petition of KATHERINE FITTIN for a SPECIAL EXCEPTION TO ALLOW THE PARKING OF ONE (1) MOBILE HOME AS A TEMPORARY RESIDENCE on the West 1/2 of Tract No. 1, being a part of an unrecorded plat of Section 8, Township 43 South, Range 40 East, being more particularly described as follows: Commencing at the Northeast corner of said Section 8, run thence South 89°38'55" West along the North line of Section 8, a distance of 330 feet to the POINT OF BEGINNING; thence continue South 89°38'55" West along the North line of Section 8, a distance of 330 feet; thence South 01°56'58" West, a distance of 660 feet; thence North 89°38'55" East, a distance of 330 feet; thence North 01°56'58" East, a distance of 660 feet to the POINT OF BEGINNING; SUBJECT to an easement over the North 100 feet thereof and over the East 30 feet of said Tract 1. Said property located on the south side of Cole Road, approximately .1 mile west of 56th Court in an AG-Agricultural District, was approved as advertised subject to the following condition:
