MOORE for a SPECIAL EXCEPTION TO ALLOW THE PARKING OF ONE (1) MOBILE HOME AS A TEMPORARY RESIDENCE on a parcel of land commencing at the Northeast corner of Section 8, Township 43 South, Range 40 East; thence South 89°38'55" West along the North line of said Section 8, a distance of 1650 feet to a point; thence South 01°56'58" West parallel with the East line of said Section 8, a distance of 660 feet to the POINT OF BEGINNING; thence continuing South 01°56'58" West a distance of 660 feet; thence North 89°38'55" East parallel with the North line of said Section 8, a a distance of 330 feet; thence North 01°56'58" West parallel with the East line of said Section 8, a distance of 660 feet; thence South 89°38'55" West parallel with the North line of said Section 8, a distance of 330 feet to the POINT OF BEGINNING; Together with and Subject to a right of way for ingress
