HORSLEY, by Kirk Friedland, Esquire, for a SPECIAL EXCEPTION TO ALLOW THE SALE OF NEW AND USED AUTOMOBILES, TRUCKS AND BOATS AS AN ADDITIONAL USE TO THE EXISTING RECREATIONAL VEHICLE SALES LOT AND REPAIR FACILITY, APPROVED UNDER ZONING PETITION No. 78-223 on the West 200 feet of the South 425 feet of the East 1/2 of Tract 7, Block 9, Palm Beach Farms Company Plat No. 3, in Section 36, Township 43 South, Range 41 East, as recorded in Plat Book 2, page 46, except part taken for State Road No. 80. Said property located on the north side of S.R. 80, approximately .2 mile west of S.R. No. 7 in a CG-General Commercial District, was approved as advertised subject to the following conditions:
