## RESOLUTION APPROVING ZONING PETITION

Cochrane, Vice President, to MODIFY the following Special Condition placed on Zoning Petition No. 74-195:

Condition No. 8 states:
8) Developer agrees to provide \$635,000 toward construction of a four (4) lane urban section of Indiantown Road as approved by the County Engineering Department from the Intracoastal Waterway to Alt. A-1-A and Alt. A-1-A from the intersection of Indiantown Road south along the west boundary line of the subject property to the terminus of the subject Planned Unit Development property.

Request: MODIFY Condition No. 8 to read: 8) Developer agrees to provide fees as required by Palm Beach County's "Fair Share Contribution for Road Improvements Ordinance".
