## RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 79-274 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 27 December 1979; and

- 3. The proposal would be consistent with the needs of the County for land areas for specific purposes to serve population and economic activities
