RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 80-104 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 26 June 1980; and

- 3. The proposal would be consistent with the needs of the County for land areas for specific purposes to serve population and economic activities
- 4. The proposal would not be disruptive to the character of the neighborhoods or adverse to playgrounds, parks, schools and recreation areas

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 23rd day of June, **1980** , that Petition No. 80-104 the petition of NABIL HANSEN and ARMO HANSEN by Nabil Hansen, Agent, for the REZONING, FROM RM-RESIDENTIAL MULTIPLE FAMILY DISTRICT (MEDIUM DENSITY) TO RH-RESIDENTIAL MULTIPLE FAMILY DISTRICT (HIGH DENSITY) of Lot 4, Block 3, (less the North 1/4, the South 252.75 feet, the East 303.00 feet, measured along the North and South lines, and the right-of-way of Military Trail thereof), Palm Beach Plantations, in Section 12, Township 44 South, Range 42 East, as recorded in Plat Book 10, page 20. Said property located on the west side of Military Trail (S.R. 809), approximately 850 feet south of Forest Hill Boulevard, was approved as advertised.
