RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

- 4. The proposal would not be disruptive to the character of the neighborhoods or adverse to playgrounds, parks, schools and recreation areas

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 25th day of September, 1980 , that Petition No. 80-171 the petition of SAL J. FRASCO for the REZONING, FROM CN-NEIGHBORHOOD COMMERCIAL DISTRICT TO CG-GENERAL COMMERCIAL DISTRICT on Lots 15, 16, 17 and 18, Block 31, Westgate Estates (Northern Section1 in Section 30, Township 43 South, Range 43 East, as recorded in Plat Book 8, page 38. Said property located on the south side of Westgate Avenue, approximately 280 feet west of Wabasso Drive, was approved as advertised.
