NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 23rd day of October 1980, that Petition No. 80-204 the petition of BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY by Dennis Koehler, Chairman, for a SPECIAL EXCEPTION TO ALLOW THE EXCAVATION AND REMOVAL OF MUCK, SAND, SHELL, ROCK, SOIL, OR OTHER EXTRACTIVE MATERIAL on the Southwest 1/4 of Section 12, Township 44 South, Range 41 East, less the South 173.00 feet and less the East 40 feet of the North 2494.59 feet. Said property located on the north side of Forest Hill Boulevard, approximately .5 mile west of S.R. 7 (U.S. 441) in a PO-Public Ownership District, was approved as advertised.
