NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 29th day of January, 1981. , that Petition No. 80-235 the petition of JAMES TRINDADE and JULES S. MINKER by John W. Ewseychik, Jr., Agent, for the REZONING, FROM IL-LIGHT INDUSTRIAL DISTRICT TO CG-GENERAL COMMERCIAL DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A PLANNED COMMERCIAL DEVELOPMENT on the South 230.20 feet of, the West 270.15 feet of the East 1/2 of Tract 65 and that part of the East 1/2 of Tract 76 lying North of State Road 80, less the Southerly 100.00 feet thereof, all in Block 5, Palm Beach Farms Co. Plat No. 3, in Section 34, Township 43 South, Range 42 East, as recorded in Plat Book 2, pages 45 through 54. Said property located at the northwest corner of the intersection of Southern Boulevard (S.R. 80) and Jog Road North (State Avenue), was denied as advertised, without prejudice.
