RESOLUTION APPROVING ZONING PETITION

No. 81-104 the petition of BARBARA JANE ROBERTSHAW for the REZONING,, FROM AG-AGRICULTURAL DISTRICT TO RT-RESIDENTIAL TRANSITIONAL DISTRICT of the West 1/2 of the North 300 feet of Tract 62, Block 11, Palm Beach Farms Company, Plat No. 3 in Section 8, Township 44 South, Range 42 East, as recorded in Plat Book 2, page 46, subject to a road

easement for ingress and egress over the North 20 feet of the East 1/2 of Tract 62 and over the North 20 feet of the East 150 feet of the West 1/2 of Tract 62. Said property located approximately 300 feet west of 82nd Drive South (Marginal Road) and approximately 300 feet north of Dillman Road, was approved as advertised.
