NO. 77-170 TO INCLUDE AN AUTOMOBILE REPAIR AND SERVICE FACILITIES, INCLUDING COMMERCIAL NEW AND USED TRUCK SALE, RENTAL AND REPAIR FACILITIES AND LOTS on the East 1/2 of the West 1/2 of the East 1/2 of the East 1/2 of the Northeast 1/4 and the West 29.98 feet of the East 1/2 of the

East 1/2 of the East 1/2, of the Northeast 1/4 all being in Section 24, Township 42 South, Range 42 East, less the South 2260.21 feet thereof and less the limit access right-of-way of S.R.
