RESOLUTION DENYING ZONING PETITION 82-26 Special Exception

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 25th day of February, 1982 , that Petition No. 82-26 the petition of MARIE SUMMERLOT CESLOW for a SPECIAL EXCEPTION TO ALLOW AN ADULT CONGREGATE LIVING FACILITY on the West 250 feet of the North 240 feet of the South 1830 feet of said Section

22, Township 41 South, Range 42 East, said distances being measured along lines parallel to the West and South Section Lines; subject to a road easement for ingress and egress over the Easterly 40 feet thereof. Said property located on the west side of 69th Drive, approximately .3 mile north of Donald Ross Road in an AR-Agricultural Residential District, was denied as advertised.
