No. 82-68 the petifion of FIRST NATIONAL BANK AND TRUST OF RIVIERA BEACH, TRUSTEE, by Alan Strassler, Agent, for a SPECIAL EXCEPTION TO AMEND THE SITE PLAN PREVIOUSLY APPROVED UNDER ZONING PETITION NO. 78-297 on Lot 8, Lot 9 and the South 83 feet of Lot 10, less the West

20 feet thereof, Suburban Homesites, in Section 24, Township 43 South, Range 42 East, as recorded in Plat Book 18, page 20. Said property located on the east side of Military Trail (S.R. 809), approximately 850 feet north of Okeechobee Boulevard (S.R. 704) in a CG-General Commercial District, was approved as advertised subject to the following conditions:

- 1. Developer shall not be permitted a median opening on Military Trail.
