RESOLUTION DENYING ZONING PETITION 82-106. REZONING AND SPECIAL EXCEPTION

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 26th day of August, 1982, that Petition No. 82-106, the Petition of JIFFY LUBE INTERNATIONAL LIMITED #1, by Alan J. Ciklin, Attorney, for the REZONING, FROM AR-AGRICULTURAL RESIDENTIAL DISTRICT TO CG-GENERAL COMMERCIAL DISTRICT, WITH A FURTHER SPECIAL EXCEPTION TO ALLOW AN OIL AND LUBE FACILITY on Lots 62 and 63, Second Addition to Country Club Acres, in Section 13, Township 46 South, Range 42 East as recorded in Plat Book 24, page 21. Said property located on the northeast corner of the intersection of Military Traiil (S.R. 809) and Jefferson Road, was denied as advertised.
