Less the South 30 feet of said Tracts and conveyed to the County of Palm Beach for Road Purposes. Said property located on the north side of Boynton West Road

(S.R.804), approximately 1/2 mile west of the Sunshine State Parkway was approved as advertised subject to the following conditions:
