## RESOLUTION NO. R-83-1110

RESOLUTION APPROVING ZONING PETITION 23-97, Rezoning

MHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHETEAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Reach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 83-97 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 28th July 1983; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

MHEREAS, the Board of County Commissioners made the following findings of fact:

- 1. The proposed rezoning and special exception are consistent with the requirements of the Comprehensive Plan.
- 2. With minor revision to the site plan, the property can be developed for the intended use meeting all property development regulations.
- 3. With proper screening this property should not have any adverse impact upon adjoining properties.

Township 46 South, Punge 42 Past, Palm Beach County, Florida, being
sore particularly described as follows:
