- 3. Since the auto repair activity is conducted entirely within an enclosed building, no adverse impact upon abutting properties should result from approval of this request.

 The development shall retain onsite 85% of the storm Jater runoff generated by a three (3) year storm per requirements of the Permit Section, Mand Development Division.
