RESOLUTION DENYING ZONING PETITION 84-55, Special Exception

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this the 27th of April 1984, petition of FIRST CHURCH OF CHRIST SCIENTIST By Elaine Curtis, for a SPECIAL EXCEPTION TO ALLOW A CHURCH on Lot 1, Block 1, Section 1, Bermuda Terrace, in Section 25, Township 40 South, Range 42 East, as recorded in Plat Book 25, Page 23. Said property located on the north side of Tequesta Drive, approximately .1 mile east of Country Club Drive in an RS-Residential Single Family District was denied, with prejudice, as advertised.
