Rightsell, Agents, for the REZONING, FROM RH-RESIDENTIAL MULTIPLE FAMILY DISTRICT (HIGH DENSITY) TO LIGHT INDUSTRIAL DISTRICT on Tract 84, Model Land Company Subdivision of Section 20, Township 44 South, Range 43 East, as recorded in Plat Book 5, Page 79, Less the West 132 feet; and Less the East 56 feet of the West 188 feet of the South 250 feet; and Less the East 100 feet of the South 75 feet of the North 314 feet thereof. Said property located on the northside of 4th Avenue North, approximately . 1 mile west of Boutwell Road was

approved as advertised.
