RESOLUTION APPROVING ZONING PETITION 85-53, Rezoning

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided **for** in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 85-53 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on the 23rd May 1985; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

WHEREAS, the petitioner agreed that reasonable precautions shall be exercised during site development to insure that unconfined particulates (dust particles) from this property do not become a nuisance to neighboring properties; and

WHEREAS, the petitioner agreed that reasonable measures shall be employed during site development to insure that no pollutants from this property shall enter adjacent **or** nearby surface waters; and

WHEREAS, the petitioner agreed that the development shall retain onsite the first one inch of the stormwater runoff per Palm Beach County Subdivision and Platting Ordinance 73-4, as amended; and

WHEREAS, the petitioner agreed that the property owner shall convey for the ultimate right-of-way of Lawrence Road, 40 feet from centerline approximately an additional 7 feet within 90 days of adoption of the Resolution by the Board of County Commissioners; conveyance must be accepted by Palm Beach County prior to issuance of first Building Permit; and

WHEREAS, the petitioner agreed that he shall present a

notarized Affidavit of Disclosure at the Zoning Authority Meeting; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and Zoning Code.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this the 23rd of May 1985, that Petition No. 85-53 the petition of MERLE N AND CAROL A JACOBS By Peter Schneider, Agent for the REZONING, FROM AR-AGRICULTURAL RESIDENTIAL DISTRICT TO RS-RESIDENTIAL SINGLE FAMILY DISTRICT on a certain parcel in the Southwest 1/4 of the Southwest 1/4 of Section 18, Township 45 South, Range 43 East, being more particularly described as follows:

Commencing at the Southwest corner of Section 18, Township 45 South, Range 43 East, run thence North 4 degrees 19'15" East along the West line of said Section 18, (the South line of said Section 18 is assumed to bear East-West and all bearings mentioned herein are relative thereto), a distance of 220.61 feet to Point of Beginning of the herein described parcel; thence East parallel with the South line of said Section 18, and running along the South line of that certain parcel described in Official Records Book 369, Page 582, a distance of 158.09 feet; thence North 4 degrees 19'15" East parallel with the West line of said Section 18, a distance of 97.70 feet; thence West parallel with the South line of said Section 18, a distance of 158.09 feet to the West line of said Section 18; thence South 4 degrees 19'15" West along said Section line, a distance of 97.70 feet, more or less, to the Point of Beginning.
