

RESOLUTION NO. R- 86-111

RESOLUTION APPROVING ZONING PETITION 85-115, Rezoning

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 85-115 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on the 30th October 1985; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and Zoning Code.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this the 30th of October 1985, that Petition No. 85-115 the petition of JOHN E. CORBALLY, JAMES FURMAN AND DAVID M. MURDOCH, TRUSTEES By Russell L. Bielenberg, Agent, for the REZONING, FROM AR-AGRICULTURAL RESIDENTIAL DISTRICT TO RM-RESIDENTIAL MULTIPLE FAMILY DISTRICT (MEDIUM DENSITY) on a parcel of Land in Section 35, Township 42 South, Range 42 East, being more particularly described as follows:

The West 500 feet of: the East 590 feet of the South 3026 feet of the East 1/2 of said Section 35. Said property located on the west side of Haverhill Road, approximately .3 mile south of Dyer Boulevard (68th Road North) was approved as advertised.

Commissioner Wilken , moved for approval of the


