Petition No. 79-177(C)

Petitioner shall construct: A pedestrian or bicycle crossing across L.W.D.D. E-3 Canal, other than N.W. 22nd Avenue.

REQUEST: TO DELETE CONDITION NO. 2a.

Said property located on the west side of Military Trail (S.R. 809) and the east side of Jog Road, and being bounded on the north by L.W.D.D. Lateral Canal No. 21, being bounded on the south by the Boynton Canal in an RT-Residential Transitional District was approved as advertised subject to the following conditions:

- The developer shall provide the minimum recreation area-and amenities for each housing pod as shown on the approved Master Plan (Exhibit No. 40).
- 2. The petitioner shall continue to be bound by all previously approved conditions unless modified herein.
- 3. Condition No. 2.a. which states:
