WHEREFIS, the application and engineering plans, calculations etc. to construct well and/or septic tank must be submitted to the Health Department prior to issuance of a building permit; and

WHEREFIS, this development shall retain onsite the first one inch of the stormwater runoff per Palm Beach County Subdivision and Platting Ordinance 73-4, as amended. The drainage system shall be maintained in an acceptable condition per the County Engineer's approval; and

WHEREAS, the Board of County Commissioners made the following findings of fact:
