RESOLUTION FIPPROVING ZONING PETITION 79-132(A), Special Exception

WHERERS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREFIS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREFIS, Petition No. 79-132(A) was presented to the Board of County Commissioners of Palm Beach County, sitting a5 the Zoning Authority, at it5 public hearing conducted on October 23, 1986 and

WHEREFIS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

WHERERS, the Board of County Commissioners made the following findings of fact:

1. With required site plan modifications, this proposal will be consistent with the requirements of the Comprehensive Plan and Zoning Code.

PROPERTIES, INC., By Kieran J. Kilday, Agent, for a SPECIFIL EXCEPTION TO FIMEND THE SITE PLAN FOR A PLANNED COMMERCIFIL DEVELOPMENT IN EXCESS OF 50,000 SQUGRE FEET, PREVIOUSLY FIPPROVED UNDER ZONING PETITION NO. 79-132, TU INCREFISE BUILDING SQUFIRE FOOTFIGE AND TO ALLOW A RECREFITIONGL FFICILITY, FIMUSEMENTS, ATTRACTIONS FIND EXHIBITS, FIND A REDESIGN OF THE SITE commencing at a point 40 feet South of the North line of Section 6, Township 45 South, Range 43 East, and the Westerly Right-of-way line of Congress Road as now established, go Southerly and Easterly Petition No. 79-132(A) Page 1
