

RESOLUTION NO. R- 87-1171

RESOLUTION RPPROVING ZONING PETITION 77-65(A): Rezoning

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 77-65(A) was presented to the Board of County Commissioners of Palm Beach County, sitting as the Zoning Authority, at its public hearing conducted on Rpril 24, 1387 and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

UHERERS, this approval is subject to Zoning Code Section 402.9 (Mandatory Review of Development Approvals) and other provisions requiring that development commence in a timely manner; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PRLM BERCH COUNTY, FLORIDR, that Petition No.77-65(A), the petition of GRLLO, ELMORE, BELLIS, DRVIMOS, ROBERTS, SRBGR, VAZQUES, FOX, MORSE OPERRTIONS, INC., GEORGE, ROUTH, MYHRE, WINKER, VIRTUE, LUHRS, SOUTH LAC DEVELOPMENT CO., LE LRC PROPERTY OWNERS RSSOCIQTION INC., by David S. Pressly, Esquire, for a REZONING, FROM RTS-RESIDENTIAL TRRNSITIONQL SUBURBRN ZONING DISTRICT TO RE-RESIDENTIRL ESTATE ZONING DISTRICT on all of the

Plat of Le Lac, according to the Plat thereof, as recorded in Plat Book 39, Pages 145 and 146. Together with the following described parcel: a portion of the Southwest 1/4 of Section 35, Township 46 South, Range 42 East, more particularly described as follows: Commencing at the Southwest Corner of said Section 35, Thence North 00 degrees 04' 18" East along the West line of said Section 35, a distance of 25.0 feet to the North Right-of-way Line Clint Moore Road as recorded in Deed Book 784, Page 153 and the Point of Beginning of this description; Thence continue North 0 degrees 04' 18" East along said West line of said Section 35, a distance of 644.82 feet to the Northwest Corner of the South 1/2 of the South 1/4 of the Southwest 1/4 of said Section 35; thence South 89 degrees 46' 26" East along the Southerly line of "Le Lac" Subdivision according to the Plat thereof, as Recorded in Flat Book 39, Pages 145 and 146 a Distance of 2014.31 feet to the West Line of Lot 3 of said "Le Lac" Subdivision; thence South 00 degrees 03' 50" East, along said West Line, a distance of 334.97 feet to the Southwest corner of said Lot 3; Thence South 89 degrees 46' E1" East along the South Line of said Lot 3, a distance of 672.56 feet to an Intersection with the East Line of the Southwest 1/4 of said Section 35; Thence South 00 degrees 02' 06" West along said East Line of Southwest 1/4, a distance of 309.03 feet to an intersection with the North Right-Of-Way Line of Clint Moore Road; Thence North 89 degrees 47' 28" West along said North Right-of-way Line of 25.0 feet North of and parallel with, as measured at Right Angles to the South Line of said Section 35, a distance of 2,687.85 feet to the Point of Beginning. The property located on the north side of Clint Moore Road approximately .5 miles west of Military Trail (SR 809) was approved as advertised.
