

RESOLUTION NO. R-88 -157

RESOLUTION WITHDRAWING ZONING PETITION S86-28

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. S86-28 was presented to the Board of County Commissioners of Palm Beach County, sitting as the Zoning Authority, at its public hearing conducted on November 18, 1986 and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA that: Petition No. S86-28 (regarding Zoning Petition No. 82-137, Resolution No. R-83-1033), the petition of the Board of County Commissioners, by Karen T. Marcus, Chairman, for a rezoning from CG-General Commercial Zoning District to RH-Multiple Family Residential Zoning District on Lots 1 through 16 and Lots 43 through 46, Block 25, West Gate Estates, in Section 30, Township 43 South, Range 43 East as recorded in Plat Book 8, Page 38, located on property on the north side of Westgate Avenue and on the south side of Cherokee Avenue, approximately 350 feet west of Wabasso Avenue, was withdrawn, without prejudice.

A motion to withdraw, without prejudice, Petition No. S86-28 was offered by Commissioner Owens, who moved its adoption. The motion was seconded by Commissioner Adams, and upon being put to a vote, the vote was as follows:
