RESOLUTION AFFROVING ZONING PETITION NO. 87-89 REZONING FETITION OF THE SCHOOL BOARD OF PALM BEACH COUNTY

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Petition No. 87-89, the petition of THE SCHOOL BOARD OF PALM BEACH COUNTY, for a REZONING FROM AR-AGRICULTURAL RESIDENTIAL ZONING DISTRICT, TO RTS-RESIDENTIAL TRANSITIONAL SUBURBAN ZONING DISTRICT, on the East 1/2 of the Southwest 1/4 of the Northwest 1/4 of the Southeast 1/4 of Section 27, Township 46 South, Range 42 East and a Parcel of Land more particularly described as follows: The Southeast 1/4 of the Northwest 1/4 of the Southeast 1/4 of Section 27, Township 46 South, Range 42 East, located approximately 250 feet east of the proposed Carter Jog Road Extension, and approximately 1.25 miles west of Military Trail (SR 809), was approved as advertised.
