## RESOLUTION APPROVING ZONING PETITION NO. 89-119 REZONING PETITION OF DALE W. ALEXANDER

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code have been satisfied; and

WHEREAS, Petition No. 89-119 was presented to the Board of County Commissioners of Palm Beach County, sitting as the Zoning Authority, at its public hearing conducted on November 30, 1989; and

WHEREAS, the Board of County Commissioners, sitting as the Zoning Authority, has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations.

WHEREAS, 402.5 of the Zoning Code requires that the action of the Board of County Commissioners, sitting as the Zoning Authority, be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Petition No. 89-119, the petition of DALE W. ALEXANDER, BY KIERAN J. KILDAY, AGENT, for a REZONING FROM RM-MULTIPLE FAMILY RESIDENTIAL ZONING DISTRICT (MEDIUM DENSITY) TO IL-LIGHT INDUSTRIAL ZONING DISTRICT on a parcel of land lying in the West 245.00 feet of the North 1/2 of the East 1/2 of Tract 2, Block 6, Palm Beach Farms Company Plat NO.3, Plat Book 2, Pages 45 through 54, Section 27, Township 43 South, Range 42 East, being located on the South side of Belvedere Road, approximately .2 mile East of Golden Lakes Boulevard (75th Avenue North) was approved on November 30, 1989, as advertised.
