WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code have been satisfied; and

WHEREAS, Petition No. 90-35 was presented to the Board of County Commissioners of Palm Beach County, sitting as the Zoning Authority, at its public hearing conducted on June 28, 1990; and

WHEREAS, the Board of County Commissioners, sitting as the Zoning Authority, made the following findings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land-development regulations.

WHEREAS, 402.5 of the Zoning Code requires that the action of the Board of County Commissioners, sitting as the Zoning Authority, be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Petition No. 90-35, the petition of THE BOARD OF COUNTY COMMISSIONERS, BY CAROL ELMQUIST, CHAIR, for a REZONING FROM AR-AGRICULTURAL RESIDENTIAL ZONING DISTRICT TO AP-AGRICULTURAL PRODUCTION ZONING DISTRICT on parcels of land, being all property in the unincorporated sections of Palm Beach County, Section 21, Township 42 South, Range 40 East and all sections lying within the AP-AGRICULTURAL PRODUCTION ZONING DISTRICT of Range 35, 36, 37, 38, 39 and 40 East and Township 40, 41, 42, 43, 44, 45, 46 and 47 South and location being all properties lying in unincorporated Palm Beach County having a 1989 Comprehensive Land Use Plan Designation of AP-AGRICULTURAL PRODUCTION ZONING DISTRICT which are presently zoned AR-AGRICULTURAL RESIDENTIAL ZONING DISTRICT, was approved on June 28, 1990, as advertised.
