NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Petition No. 85-136(A), the petition of BOARD OF COUNTY COMMISSIONERS, BY CAROL ELMQUIST, CHAIR, to REVOKE A SPECIAL EXCEPTION FOR A PLANNED UNIT DEVELOPMENT on a parcel of land lying south of the southerly right of way line of Westgate Avenue, as shown in Road Plat Book 2, Page 205, being the southeast 3 of the northeast 3 of the northeast 3 of section 25, township 43 south, range 42 east, and north # of the northeast 3 of the southeast 3 of said section 25, and being located on the S.
