RESOLUTION APPROVING RECOMMENDATION OF STATUS REPORT NO. SR 87-19
TO AMEND CONDITIONS OF APPROVAL OF RESOLUTION NO. R-87-1203
WHICH APPROVED THE SPECIAL EXCEPTION OF VIRGIL AND JEAN CHRISTOPHER PETITION NO. 87-19

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, systematic monitoring and review of approved zoning actions help implement the goals and objectives of **the** Comprehensive Plan.

WHEREAS, the notice and hearing requirements as provided for in Section 402.9 of the Palm Beach County Zoning Code have been satisfied; and

WHEREAS, pursuant to Section 402.9, Status Report SR 87-19 was presented to the Board of County Commissioners of Palm Beach County, sitting as the Zoning Authority, at a public hearing conducted on January 2, 1991; and

WHEREAS, the Board of County Commissioners, sitting as the Zoning Authority, has reviewed Status Report SR 87-19 and considered testimony presented by the applicant and other interested parties, and the recommendations of the various county review agencies; and

WHEREAS, Section 402.9 **of** the Palm Beach County Zoning Code authorizes the Board of County Commissioners, sitting as the Zoning Authority, to add or modify conditions of approval; and

WHEREAS, the Board of County Commissioners, sitting as the Zoning Authority, made the following findings of fact:

- 1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations; and
- 2. The conditions listed below require this petition to develop more in conformity with current standards of development.

WHEREAS, Section 402.5 of the Zoning Code requires that the action of the Board ${\bf of}$ County Commissioners, sitting as the Zoning Authority, be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that the recommendation of Status Report No. SR 87-19, amending Conditions of Approval of Resolution No. R-87-1203, the Special Exception of Virgil and Jean Christopher, Petition No. 87-19, on Tract 20, EXCEPT the South 330.6 feet thereof and Tracts 17, 18 and 19, Block 18 according to the Plat thereof of PALM BEACH FARMS COMPANY PLAT NO. 3, as recorded in Plat Book 2, Pages 45 to 54, of the Public Records of Palm Beach County, Florida, being located on the west side of S.R. 7 (U.S. 441) approximately 0.2 of a mile north of Forest Hill Boulevard (20th Avenue South), in an AR-Agricultural Residential Zoning District, is approved, as amended, subject to the following conditions:

- 1. The petitioner shall comply with all previous conditions of approval unless expressly modified herein.
- 2. Prior to August 11, 1991, the site plan shall be amended to comply, to the maximum extent possible, with the 1990 Palm Beach County Landscape Code.
