WHEREAS, pursuant to Section 402.9, Status Report SR 88-68 was presented to the Board of County Commissioners of Palm Beach County, sitting as the Zoning Authority, at **a** public hearing conducted on June 27, 1991; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD **OF** COUNTY COMMISSIONERS **OF** PALM BEACH COUNTY, FLORIDA, that the recommendation of Status Report No. SR 88-68, to revoke the Special Exception previously granted by the approval of the petition of **Boca** Commerce Park, Inc., Petition No. 88-68, which permitted **a** restaurant and lounge, **on** Tract **8**, of Florida Fruit Lands **Co.,'s** subdivision **No. 2 of** Section **1**, Township 47 South, Range 41 East, as recorded in Plat Book 1, Page 102, lying West **of** the Right-of-Way line **of** U.S. 441 (SR 7), being located on the west side of State Road #7 (U.S. #441) approximately 0.4 of a mile North of Yamato Road, is approved,
