## RESOLUTION AMENDING RESOLUTION NO. R-91-994 RESOLUTION APPROVING ZONING PETITION OF HARRELL A. & CAROL L. CHAMPION, RAFFAELE, MICHELANGELO, & KIM TROPEANO PETITION NO. 91-19

WHEREAS, HARRELL A. AND CAROL L. CHAMPION, RAFFAELE, MICHELANGELO, AND KIM TROPEANO petitioned the Palm Beach County Planning Commission and the Board of County Commissioners, sitting as the final zoning authority, on April 4, 1991 and April 25, 1991, respectively, for the SPECIAL EXCEPTION FOR OPEN STORAGE OF BUILDING SUPPLIES.

WHEREAS, Resolution No. R-91-994 adopted confirming the action of the Board of County Commissioners sitting as the final zoning authority on April 25, 1991, inadvertently contained a scrivener's error within Condition No. E.4.; and

"E.4. Prior to Site Plan approval by the Site Plan Review Committee the property owner shall record a Unity of Title on the subject property subject to approval by the County Attorney."

WHEREAS, Condition No. E.4. of Zoning Resolution NO. R-91-944 should have read:

E.4. Prior to Site Plan approval by the Site Plan Review Committee the property owner shall record a Unity of Control on the subject property subject to approval by the County Attorney.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS **OF** PALM BEACH COUNTY, FLORIDA, that:

- 1. The foregoing recitals are hereby affirmed and ratified.
- 2. Condition No. E.4. of Resolution No. R-91-994 is amended.
