RESOLUTION APPROVING RECOMMENDATION OF STATUS REPORT NO. SR 84-32(B) TO REZONE PROPERTY PREVIOUSLY REZONED BY RESOLUTION NO. R-84-1108 APPROVING THE PETITION OF JOHN F. FIELD AND WILLIAM H. FIELD PETITION NO. 84-32

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, systematic monitoring and review of approved zoning actions help implement the goals and objectives of the Comprehensive Plan.

WHEREAS, the notice and hearing requirements as provided for in Section 402.9 of the Palm Beach County Zoning Code have been satisfied; and

WHEREAS, pursuant to Section 402.9, Status Report SR 84-32 was presented to the Board of County Commissioners of Palm Beach County, sitting as the Zoning Authority, at a public hearing conducted on September 26, 1991; and

WHEREAS, the Board of County Commissioners, sitting as the Zoning Authority, has reviewed Status Report SR 84-32 and considered testimony presented by the applicant and other interested parties, and the recommendations of the various county review agencies; and

WHEREAS, Section 402.9 of the Palm Beach County Zoning Code authorizes the Board of County Commissioners, sitting as the Zoning Authority, to rezone property; and

WHEREAS, the Board of County Commissioners, sitting as the Zoning Authority, made the following findings of fact:

- 1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations; and
- 2. The rezoning will eliminate an inconsistency with the Palm Beach County Comprehensive Plan.

WHEREAS, Section 402.5 of the Zoning Code requires that the action of the Board of County Commissioners, sitting as the Zoning Authority, be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that the recommendation of Status Report No. SR 84-32(B), to rezone the property to CC-Community Commercial Zoning District, which was previously rezoned to CG-General Commercial Zoning District by the approval of the petition of John F. Field and William H. Field, Petition No. 84-32, on a parcel of land lying on the South 120.00 feet of the North 880.00 feet of the East 1/2 of the Northeast 1/4of the Northeast 1/4 of Section 7, Township 44 South, Range 43 East, less the East 60.00 feet for road Right-of-way. Also known as Lot 7, Palm Acres No. 1, unrecorded, being located on the west side of Congress Avenue (S.R. #807), approximately 0.4 of a mile south of Summit Boulevard, is approved. .'
