JOHN T. CHRISTIANSEN AND **JAMES D. LASSITER**  
PETITION NO. 85-150

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, systematic monitoring and review of approved zoning actions help implement the goals and objectives of the Comprehensive Plan.

WHEREAS, the notice and hearing requirements as provided for in Section 402.9 of the Palm Beach County Zoning Code **have been** satisfied; and

WHEREAS, pursuant to Section 402.9, Status Report SR 85-150.5 **was** presented to the Board of County Commissioners of Palm Beach County, sitting as the Zoning Authority, at a public hearing conducted **on** April 23, 1992; and

WHEREAS, the Board of County Commissioners, sitting as the Zoning Authority, has reviewed Status Report SR 85-150.5 and considered testimony presented by the applicant and other interested parties, and the recommendations of the various county review agencies; and

WHEREAS, Section 402.9 of the Palm Beach County Zoning Code authorizes the Board of County Commissioners, sitting as the Zoning Authority, **to** add or modify conditions of approval; and

WHEREAS, the Board of County Commissioners, sitting as the Zoning Authority, made the following findings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations; and
2. The conditions listed below require this petition to develop more in conformity with current standards of development.

WHEREAS, Section 402.5 of the Zoning Code requires that the action of the Board of County Commissioners, sitting as the Zoning Authority, be adopted by resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that the recommendation of Status Report No. SR 85-150.5, amending Conditions of Approval of Resolution No. R-86-236, the Special Exception of John T. Christiansen and James D. Lassiter, Petition No. 85-150, which granted a Special Exception to allow a Planned Office Business Park, on Lot 1, Block 3, Laguna Park No. 2, in Section 7, Township 44 South, Range 43 East, as recorded in Plat Book 21, Page 65, being located on the southwest corner of the intersection of Congress Avenue and Melaleuca Road, in a CS-Specialized Commercial Zoning District, is approved, subject to the following conditions:**

1. The petitioner shall comply with all previous conditions of approval unless expressly modified herein.
2. Prior to September 30, 1992, the property shall submit,

and have certified, a site plan which complies to the maximum extent possible with the landscape code in effect at that time.

Commissioner Roberts moved for approval of the Resolution.
