RESOLUTION AMENDING RESOLUTION NO. R-84-1173  
RESOLUTION APPROVING ZONING PETITION OF  
HOSPITAL CORPORATION OF AMERICA, A TENNESSEE CORPORATION  
PETITION NO. 84-54

WHEREAS, HOSPITAL CORPORATION OF AMERICA, A TENNESSEE CORPORATION, petitioned the Palm Beach County Planning Commission and the Board of County Commissioners, sitting as the final zoning authority, on April 5, 1984 and April 27, 1984, respectively, for a SPECIAL EXCEPTION TO ALLOW A MEDICAL CENTER; and

WHEREAS, Resolution No. R-84-1173 adopted August 21, 1984, confirming the action of the Board of County Commissioners sitting as the final zoning authority on April 27, 1984, inadvertently contained an error in the legal description; and

WHEREAS, the legal description of Zoning Resolution No. R-84-1173 reads as follows:

"on the West 100.00 feet of Lot 2 and all of Lot 3, Block R of the replat of Loxahatchee District Subdivision, Loxahatchee Groves, in Section 33, Township 43 South, Range 41 East, as recorded in Plat Book 12, Page 29; Less that portion of State Road No. 80 (U.S. 98) and State Road No. 7 (U.S. 441) lying within said Lots 2 and 3 as per right-of-way map Section 93120-2521, Sheet 10 of 15, State of Florida Department of Transportation, November, 1983."; and

WHEREAS, the legal description of Zoning Resolution No. R-84-1173 should have read:

on the West 100.00 feet of Lot 2 and all of Lot 3, Block R ~~R~~ **K** of the Replat of Loxahatchee District Subdivision, Loxahatchee Groves, in Section 33, Township 43 South, Range 41 East, as recorded in Plat Book 12, Page 29; Less that portion ~~of State Road No. 80 (U.S. 98) and State Road No. 7 (U.S. 441) lying~~ **of State Road No. 80 (U.S. 98) and State Road No. 7 (U.S. 441) lying** within said Lots 2 and 3 as per right-of-way map Section 93120-2521, Sheet 10 of 15, State ~~of~~ **of** Florida Department of Transportation, November, 1983.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. The legal description of Resolution No. R-84-1173 is hereby amended.


