RESOLUTION AMENDING RESOLUTION NO. **R-89-948**  
RESOLUTION APPROVING ZONING PETITION OF RONALD LOEWENTHAL  
PETITION NO. **88-51**

WHEREAS, RONALD LOEWENTHAL petitioned the Palm Beach County Planning Commission and the Board of County Commissioners, sitting as the final zoning authority, on May 9, 1988 and May 26, 1988, respectively, for a REZONING FROM THE AR-AGRICULTURAL RESIDENTIAL ZONING DISTRICT **TO** THE RM-MULTIPLE FAMILY RESIDENTIAL ZONING DISTRICT (MEDIUM DENSITY); and

WHEREAS, Resolution No. **R-89-948**, adopted May 23, 1989, confirming the action of the Board of County Commissioners sitting as the final zoning authority on May 26, 1988, inadvertently contained an error in the legal description; and

WHEREAS, the legal description of Resolution No. **R-89-948** reads as follows:

**"on** all that part of the Northeast 1/4 of the Southwest 1/4 of Section 14, Township 46 South, Range 42 East, lying North of the North Right-of-way line of State Road 806, **as** shown in Road Plat **Book 3**, Page 26 described as follows:

Commence at the Northeast corner of the said Northeast 1/4 of the Southwest 1/4 of Section 14; thence South 00 degrees 06' 28" West along the East line of said Northeast of the Southwest 1/4 870.33 feet; thence South 88 degrees 28' 12" West parallel with the North line of the said Northeast 1/4 of the Southwest 1/4, 530.06 feet to the Point of Beginning of the lands herein described; thence continue South 88 degrees 28' 12" W, 120.00 feet; thence North 00 degrees 06' 28" East, 140.06 feet; thence South 88 degrees 28' 12" West along the South line of Heritage Park, as recorded in Plat **Book 52**, pages 75 and 76, 526.34 feet; thence South 00 degrees 18' 38" East, parallel with and 177.00 feet East of the West line of the said Northeast 1/4 of the Southwest 1/4, 649.82 feet;

thence Easterly along the North Right-of-way line of State Road 806, being the arc of a circular curve to the right, having a radius of 1,871.73 feet, an arc distance of 585.34 feet to a Point of Tangency; thence continue North 89 degrees 18' 46" East along the said North Right-of-way line, 66.81 feet; thence North 00 degrees 06' 28" East, 428.52 feet to the Point of Beginning,"; and

WHEREAS, the legal description of said zoning resolution should have read:

on all that part of the Northeast 1/4 of the Southwest 1/4 of Section 14, Township 46 South, Range 42 East, lying North of the North Right-of-way line of State Road 806, as shown in Road Plat Book 3, Page 26 described as follows:

Commence at the Northeast corner of the said Northeast 1/4 of the Southwest 1/4 of Section 14; thence South 00 degrees 06' 28" West along the East line of said Northeast 1/4 of the Southwest 1/4 ~~870.33~~ 820.33 feet; thence South 88 degrees 28' 12" West parallel with the North line of the said Northeast 1/4 of the Southwest 1/4, 530.06 feet to the Point of Beginning of the lands herein described; thence continue South 88 degrees 28' 12" W, 120.00 feet; thence North 00 degrees 06' 28" East, 140.06 feet; thence South 88 degrees 28' 12" West along the South line of Heritage Park, as recorded in Plat Book 52, pages 75 and 76, 526.34 feet; thence South 00 degrees 18' 38" East, parallel with and 177.00 feet East of the West line of the said Northeast 1/4 of the Southwest 1/4, 649.82 feet; thence Easterly along the North Right-of-way line of State Road 806, being the arc of a circular curve to the right, having a radius of 1,871.73 feet, an arc distance of 585.34 feet to a Point of Tangency; thence continue North 89 degrees 18' 46" East along the said North Right-of-way line, 66.81 feet; thence North 00 degrees 06' 28" East, 428.52 feet to the Point of Beginning, .

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. The legal description of Resolution NO. R-89-948 is hereby amended.
