RESOLUTION AMENDING RESOLUTION NO. R-89-1306
RESOLUTION APPROVING ZONING PETITION OF DAVID A. BEEMS
PETITION NO. 89-14

WHEREAS, DAVID A. BEEMS petitioned the Palm Beach County Planning Commission and the Board of County Commissioners, sitting as the final zoning authority, on March 2, 1989 and March 30, 1989, respectively, for a SPECIAL EXCEPTION TO PERMIT A PLANNED OFFICE BUSINESS **PARK**; and

WHEREAS, Resolution No. R-89-1306 adopted July 11, 1989, confirming the action of the Board of County Commissioners sitting as the final zoning authority on March 30, 1989, inadvertently contained an error in the legal description; and

WHEREAS, the legal description of Zoning Resolution No. R-89-1306 reads as follows:

"on a parcel of land lying on Lot 1, Block 3, Laguna Park No. 1 in Section 8, Township 44 South, Range 42 East, according to the Plat thereof, as recorded in Plat Book 21, Page 53. Less the Right-of-way for Congress Avenue (State Road 807),"; and

WHEREAS, the legal description of Zoning Resolution No. R-89-1306 should have read:

on a parcel of land lying on Lot 1, Block 3, Laguna Park No. 1 in Section 8, Township 44 South, Range 43 East, according to the Plat thereof, as recorded in Plat Book 21, Page 53. Less the Right-of-way for Congress Avenue (State Road 807),.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. The legal description of Resolution No. 89-1305 is hereby amended.

The foregoing resolution was offered by Commissioner Elmquist, who moved its adoption. The motion was seconded by Commissioner Roberts, and upon being put

to a vote, the vote was as follows:


