RESOLUTION AMENDING RESOLUTION NO R-89-1617  
RESOLUTION APPROVING ZONING PETITION OF JENNIFER FORSYTH  
PETITION NO 89-40

WHEREAS, JENNIFER FORSYTH petitioned the Palm Beach County Planning Commission and the Board of County Commissioners, sitting as the final Zoning Authority, on May 4, 1989 and May 25, 1989, respectively, for a SPECIAL EXCEPTION TO PERMIT COMMERCIAL KENNELS AND STABLES AND ACCESSORY BUILDINGS AND STRUCTURES (COMMERCIAL STABLE), AND

WHEREAS, Resolution No R-89-1617 adopted September 12, 1989, confirming the action of the Board of County Commissioners sitting as the final Zoning Authority on May 25, 1989, inadvertently contained an error in the legal description and an error in the adoption date, and

WHEREAS, the legal description of Zoning Resolution No R-89-1617 reads as follows

WHEREAS, the legal description of Zoning Resolution R-89-1617 should have read.

on a parcel of land lying on the South 1/2 of Lot 44, Block A, Loxahatchee Groves, Plat Book 12, Page 29, in Section 30, Township 43 South, Range 41 East,, and

WHEREAS, the adoption date of Zoning Resolution No R-89-1617 reads as follows
