in the West 245.00 feet of the North 1/2 of the East 1/2 of Tract 2, Block 6, Palm Beach Farms Company Plat No. 3, Plat Book 2, Pages 45 through 54, Section 33, Township 43 South, Range 42 East,.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

- 1. The foregoing recitals are hereby affirmed and ratified.
- 2. The legal description of Resolution No. R-90-824 is hereby amended.
