on a parcel of land lying South 168.27 feet of the East 313.00 feet of the following described parcel: The South 1/2 of the Southeast 1/4 of the Northwest 1/4, of Section 13, Township 44 South, Range 42 East, less the 53.00 feet thereof, for road right of way of (State Road 809),

- 1. The foregoing recitals are hereby affirmed and ratified.
