RESOLUTION AMENDING RESOLUTION NO. R-90-849  
RESOLUTION APPROVING ZONING PETITION OF  
DRAKE HOMES, INC., C. HAROLD DRAKE AND CAROL K. DRAKE  
PETITION NO. 89-85(A)

WHEREAS, DRAKE HOMES, INC., C. HAROLD DRAKE AND CAROL K. DRAKE petitioned the Palm Beach County Planning Commission and the Board of County Commissioners, sitting as the final zoning authority, on December 7, 1989 and December 28, 1989, respectively, for the SPECIAL EXCEPTION TO PERMIT GOVERNMENT SERVICES (STATE PROBATION AND RESTITUTION CORRECTIONAL FACILITY); and

WHEREAS, Resolution No. R-90-849 adopted May 22, 1990, confirming the action of the Board of County Commissioners sitting as the final zoning authority on December 28, 1989, inadvertently contained errors in the legal description; and

WHEREAS, the legal description of Resolution No. R-90-849 reads as follows:

"on a parcel of land lying in the West 80.00 feet of the East 220.00 feet of Tract 27, Model Land Company's Subdivision of Section 20, Township 44 South, Range 43 East, as recorded in Plat Book 5, Page 29, less the North 375.00 feet,";

WHEREAS, the legal description of said zoning resolution should have read:

on a parcel of land lying in the West ~~80.00~~ 190.00 feet of the East 220.00 feet of Tract 27, Model Land Company's Subdivision of Section 20, Township 44 South, Range 43 East, as recorded in Plat Book 5, Page ~~29~~ 79, less the North ~~375.00~~ 250.00 feet of Tract 27 and less the South 242.00 feet of Tract 27,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. The legal description of Resolution No. R-90-849 is hereby amended.

The foregoing resolution was offered by Commissioner Elmquist, who moved its adoption. The motion was seconded by Commissioner Roberts, and upon being put to a vote, the vote was as follows:
