RESOLUTION AMENDING RESOLUTION NO. R-90-1287
RESOLUTION APPROVING ZONING PETITION OF
LARRY W. HODGES, KYLE FOREMAN, **WALTER** LUZENKO, AND
JAMES ALCIDE KING
PETITION NO. 88-134

WHEREAS, LARRY HODGES, KYLE FOREMAN, WALTER LUZENKO, AND JAMES ALCIDE KING petitioned the Palm Beach County Planning Commission and the Board of County Commissioners, sitting as the final zoning authority, on January 4, 1990 and January 25, 1990, for a REZONING FROM THE CN-NEIGHBORHOOD COMMERCIAL ZONING DISTRICT TO THE CG-GENERAL COMMERCIAL ZONING DISTRICT; and

WHEREAS, Resolution No. R-90-1287 adopted August 7, 1990, confirming the action of the Board of County Commissioners sitting as the final zoning authority on January 25, 1990, inadvertently contained an error in the legal description; and

WHEREAS, the legal description of Resolution No. R-90-1287 reads as follows:

"on a parcel of land lying in Lots 3 through 8, inclusive, Block 3, according to the plat of WESTGATE ESTATES, Northern Section, as recorded in Plat Book 8 at Pages 38,"; and

WHEREAS, the legal description of said zoning resolution should have read:

on a parcel of land lying in Lots 3 through 8, inclusive, Block 3 31, according to the plat of WESTGATE ESTATES, Northern Section, as recorded in Plat Book 8 at Pages 38, and being in Section 30, Township 43 South, Ranse 43 East.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. The legal description of Resolution NO. R-90-1287 is hereby amended.

The foregoing resolution was offered by Commissioner Elmquist, who moved its adoption. The motion was seconded by Commissioner Roberts, and upon being put to a vote, the vote was as follows:


