RESOLUTION AMENDING RESOLUTION NO. R-90-1318  
RESOLUTION APPROVING ZONING PETITION OF  
NICK De FELIPPIS  
PETITION NO. 90-5

WHEREAS, NICK De FELIPPIS petitioned the Palm Beach County Planning Commission and the Board of County Commissioners, sitting as the final zoning authority, on March 1, 1990 and March 29, 1990, respectively, for a REZONING FROM THE RE-RESIDENTIAL ESTATE ZONING DISTRICT TO THE AR-AGRICULTURAL RESIDENTIAL ZONING DISTRICT; and

WHEREAS, Resolution No. R-90-1318 adopted August 7, 1990, confirming the action of the Board of County Commissioners sitting as the final zoning authority on March 29, 1990, inadvertently contained errors in the legal description; and

WHEREAS, the legal description of Resolution No. R-90-1318 reads as follows:

"on a parcel of land lying in Lot 103, Block 70, Palm Beach Farms Co. Plat No. 3, Plat Book 2, Pages 45 - 54, as in Section 27, Township 43 South, Range 42 East,; and

WHEREAS, the legal description of said zoning resolution should have read:

on a parcel of land lying in Lot 103, Block 70, Palm Beach Farms Co. Plat No. 3, Plat Book 2, Pages 45-54, as in Section ~~27~~ 31, Township ~~43~~ 46 South, Range 42 East,.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. The legal description of Resolution No. R-90-1318 is hereby amended.
