WHEREAS, the legal description of said zoning resolution should have read:

on a lease parcel of land lying in the West 309.34 feet of the East 611.88 feet of the North 575.93 feet of the South 600.93 feet of Tract 6, Block 8, PALM BEACH FARMS COMPANY, PLAT NO. 3, Section $\frac{27}{31}$, Township 43 South, Range 42 East, EXCEPTING the South 25.00 feet thereof for road right-of-way purposes,.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

- 1. The foregoing recitals are hereby affirmed and ratified.
