on a parcel of land lying on Tract 93, less the West 150.00 feet and less the South 40.00 feet and Tract 94, less the East 60.00 feet and less the South 40.00 feet of Block 77, Palm Beach Farms Company Plat No. 3, as recorded in Plat Book 2, Page 53, located in Section $\frac{10}{10}$ 18, Township 47 South, Range 42 East,.

- 1. The foregoing recitals are hereby affirmed and ratified.
