The East 329 92 feet of Tract 31, and the South 285 29 feet less the West 35 00 feet of Tract 30, Block 6, of PALM BEACH FARMS COMPANY PLAT NO 3 according to the Plat thereof as recorded in Plat Book 2 Pages 45 through 54 of the Public Records of Palm Beach County, Florida, all being in Section 32, Township 43 South Range 42 East, Palm Beach County Florida, containing 11 25 acres more or less

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that

- The foregoing recitals are hereby affirmed and ratified
